Re: Permit BR-40-BL
Adriatic "B" Zone, Italy

The operator with the consent of all participants wishes to surrender the above-noted permit.

After completion and evaluation of two separate seismic surveys, copies of both surveys, including all pertinent technical data have been forwarded to the Italian Government; it was concluded that no drillable structure exists within the permit area.

The Cretaceous, Miocene and Pliocene structures indicated from seismic are of such nature that they do not represent economically viable prospects.

The Triassic formation probably occurs at a depth of 4,500' to 5,000 meters and is therefore considered too deep for oil exploration.

It is for these reasons that the permit is being surrendered.

Dopo aver portato a termine ed aver attentamente valutato i risultati di due distinte prospezioni sismiche, copie delle quali, contenenti tutti i pertinenti dati tecnici, sono già state trasmesse alle competenti autorità italiane, si è giunti alla conclusione che nell'ambito dell'area del permesso non si rinvengono strutture da perforare.

Le strutture del Cretaceo, del Miocene e del Pliocene rilevate dalle prospezioni sismiche sono di natura tale da non rappresentare prospettive economicamente apprezzabili.

La formazione Triassica probabilmente si presenta ad una profondità dai 4.500 ai 5.000 metri ed è, pertanto, da considerarsi troppo profonda per lavori di ricerca di petrolio.

Per tali motivi viene disposta la rinuncia al Permesso.
